**TO:** Local Workforce Development Area Administrators/Service Providers

**SUBJECT:** Additional PY 2016, FY 2017 Workforce Innovation and Opportunity Act (WIOA) Title I – Adult Activities Program Allocations

- Purpose:** To issue additional allocations of PY 2016, FY 2017 WIOA Title I – Adult Activities program funds to local workforce development areas (LWDAs).
- General Information:** Training and Employment Guidance Letter Number 17-15, Change 3 informs states that the FY 2017 “advance” funding for PY 2016 is further adjusted to restore the original levels contained in TEGL No. 17-15 for the Adult and Dislocated Worker programs based on the enactment of the Consolidated Appropriations Act, 2017 on May 5, 2017. Arkansas is receiving an additional \$12,437 in Adult funds and an additional \$12,458 in Dislocated Worker funds. The State will retain the Dislocated Worker funds for Rapid Response activities but distribute the Adult funds according to formula. Each local area will receive a unilateral modification to its FY 2017 (October) Adult sub grant award as follows.
