SUBJECT: Announcement of Award of PY-16 Youth Recapture Funding

I. **Purpose:** To award funding of WIOA PY-16 Youth funding that was recaptured as of August 15, 2018, based on unexpended amounts calculated as of June 30, 2018. This action is authorized under 20 CFR § 683.110, which includes the following:

(2) Funds which are not expended by a local area(s) in the 2-year period described in paragraph (c)(1)(i) of this section, must be returned to the State. Funds so returned are available for expenditure by State and local recipients and subrecipients only during the third program year of availability in accordance with WIOA secs. 128(c) and 132(c). These funds are available for only the following purposes:

(i) For statewide projects; or

(ii) For distribution to local areas which had fully expended their allocation of funds for the same program year within the 2-year period.

These funds must be expended by June 30, 2019, and must be expended prior to PY17 or PY18 funds.

The funds are considered an additional allotment of WIOA Title I formula funds. All applicable requirements, terms and conditions that apply to the respective funding source attach to this allotment.
